## 4) Washington State Auditor's Office | 2020-2023 Audit Results and Final Report

Washington State Auditor's Office (SAO) Ruth Walker and Cinthya Medina presented to the Board an Exit Conference report (on file) for the triennial accountability audit performed for July 1, 2020 through June 30, 2023. The areas examined during the audit period were: Accounts Payable, Payroll, Open Public Meetings (compliance with minutes, meetings and executive session), and Financial Condition. ## 5) Transportation Improvement Program Amendment #2

Jeff Wilkens presented to the Board a staff report (on file). Amendment #2 was presented authorizing the expenditure of an additional \$2,528,183 in federal funding within the region by adding the Douglas County and WSDOT projects to the 2024-27 TIP.

Upon a motion by Richard DeRock, seconded by Marc Straub, the Board unanimously approved Amendment #2 to the 2024-27 Transportation Improvement Program as submitted. Motion carried.

## 6) Resolution 1-2024 | Adopting the CDTC State Route 28 Plan

Upon a motion by Kevin Overbay, seconded by Mike Poirier, the Board unanimously <u>tabled</u> Resolution 1-2024 to adopt the CDTC State Route 28 Plan <u>for 60 days</u> to accommodate the Douglas County Commission's evaluation request. Motion carried.

Upon a motion by Mike Poirier, seconded by Nick Covey, the Board unanimously authorized the CDTC Executive Director to execute a contract with Alta Planning + Design, Inc for the CDTC Regional Pathways Master Plan. Motion carried.
